The bids will be opened in the presence of Bidder's representatives who choose to attend at 13:00 hrs on 23 Manshir 2077 (08 Dec.2020) at the office of Armed Police Force, Nepal Welfare Service Center. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in PDF format, which shall be valid for 30 days beyond the validity period of the bid.
