5. Bids must be submitted to Armed Police Force Nepal Welfare Service Center Halchowk Kathmandu, Nepal through PPMO website www.bolp.ttra.gov.np/egp on or before 12:00 PM on April 30, 2021

6. The bids will be opened in the presence of Bidders' representatives at **14:00 PM** at Armed Police Force Nepal Welfare Service Center Halchowk Kathmandu, Nepal on **April 30, 2021**. Bids must be valid for a period of 90 days after bid opening date and must be accompanied by a bid security amounting of NRs 371000 which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. Eligible bidders with the following Key Qualification Criteria should participate: Key Activity experience in fabricating prefabricated Steel Structure with Panel area =670 Sq.m.

9. The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (with latest revision) and as per ITB 24 of bid documents during examination, evaluation and comparison by the *[date and Time]*.
