- 4. Pre-bid meeting shall be held at APFN HQ, Procurement Division, Halchowk, Kathmandu, 2078/01/24 at 13:00 Hrs.
- 5. Bids must be submitted through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 noon on 2078/02/05 Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidder's representatives who choose to attend at 13:00 hrs on 2078/02/05 at the office of APFN HQ, Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to above-mentioned in respective column, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If Pre-bid meeting/ bid opening /or submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The purchaser reserves the rights to accept or reject any bid and to annual the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the Bidders.
