Re-Invitation for bids

1. Armed Police Force Nepal No.43 Reserve Battalion HQ. Banbehada Kailali invites electronic bids from Nepalese eligible bidders for the construction of the following Works as specified in table (2) under National Competitive Bidding procedures. Eligible Bidders may obtain further information at PPMO website www.bolpatra.gov.np/egp and in the bidding documents. Only eligible bidders with the following key qualifications as specified in table (2) should participate in this bidding.

2. The Bidders should follow the electronic bid submission procedures mentioned in ITB 21 b of Single Stage Two envelope bidding procedure of bid document.

- 3. Eligible bidders may obtain further information and inspect the bidding documents at respective offices as specified in table (1) or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 4. Bidder who chooses to submit their bid electronically, may download the bidding documents for e-submission from PPMO e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the project's Rajaswa (revenue) account as specified in table (1)
- Pre-bid meting shall be held at the respective offices as specified in the table no (2) at 12:00 PM on February 1, 2023.
- 6. The electronic bids must be submitted to respective offices as specified in table (2) through PPMO website www.bolpatra.gov.np/egp on or before 11:00 AM on February 14, 2023.
- 7. The bids will be opened in the presence of Bidders' representatives at 11:05 AM on February 14, 2023 at respective office as specified in table (2). Bids must be valid for a period of 90 days after bid opening date.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (latest revision) and as per ITB 27 of Single Stage Two envelope bidding procedure of bid documents during examination, evaluation and comparison by the date and time given. The bidder who does not provide the clarification of its bid by the date and time set by the employer will be rejected.
- 10. Information not covered in this notice shall be in accordance with bid document. Public Procurement Act 2063 (latest revision), Public Procurement Regulation 2064 (latest revision). Electronic Procurement Directives 2074 and other prevailing Law.
